TERMS & CONDITIONS

1. The rate agreement shall be valid till 31st March 2024. The contract shall be subject to cancellation without prior intimation, if the work executed or supplies made are found unsatisfactory.
2. Any tenderer, whether individual or firm whose relatives or near relatives are working in the Sangeet Natak Akademi or its affiliated institutions, will not be eligible for any contract with the Sangeet Natak Akademi.
3. The Akademi has the right to accept or reject any tender without assigning any reason. The decision of the Akademi in this regard will be final and no correspondence will be entertained.
4. No advance payment shall be made by the Akademi.
5. The bills shall be submitted along with a copy of challans and photographs of all the work undertaken duly signed by the concerned officials of the Akademi, immediately after the function is over or the supply is made and in any case not later than 15 days after the function is over or supply is made.
6. The work shall have to be completed within stipulated time period.
7. The stage/ ambience material etc. shall be supplied at the venue of the function or at any other desired place, alongwith a copy of the challan and no conveyance, labour charges, transportation, assignment charges shall be paid by the Akademi at that time.
8. In case, if at any stage, it is found that the work executed by the contractor(s) was not satisfactory and up to the standard of the status of the event/ programme/ activity etc., then no payment shall be made. Also, if at any stage, it is found that extra payment has been made on any bill in the past, then the same shall be recovered from the current bills.
9. In case the contractor fails to comply with the order immediately, even at a short notice, the Akademi will be at a liberty to have the work executed from outside parties, at the risk and cost of the contractor.
10. In case of theft, fire, riots, natural calamities etc., the contractor(s) shall bear the loss or damage and the Akademi shall not be liable to pay for such losses/ damages.
11. The payment for hiring of material shall be subject to inspection and approval by the Akademi.

12. Relevant experience of organizing at least two similar Festival/Event/Entertainment/IEC Projects during last 3 years (with Govt./PSU's/Private should be submit alongwith the quotation.

13. GST, PAN, and ITR for last 3 years should also be submitted with the quotations.
