

ANNUAL ACTIVITY REPORT 2016-2017

The South Zone Cultural Centre at Thanjavur, Tamil Nadu was established as a Society under the Ministry of Culture, Government of India, came into existence on 31st January 1986 with the objective to integrate people of India through Culture, art and heritage. The Centre has jurisdiction over the states of Andhra Pradesh, Telangana, Karnataka, Kerala, Tamil Nadu and Union Territories of Andaman and Nicobar Islands, Lakshadweep and Puducherry.

During the year 2016-17 SZCC, in association with the Member States, has arranged around 169 programmes. More than 10,414 artistes from various parts of the country have been paid for their participation in various programmes conducted during the year. These programmes could be conducted successfully with the active participation and support of each Member State. Some of the programmes organised are highlighted below:

April 2016

Simhastha Kala Utsav 2016

Under the direction of Ministry of Culture, Government of India South Zone Cultural Centre arranged troupes from its Member States for Simhastha Kala Utsav held at Bhoj Manch, Ujjain, Madhya Pradesh. Dummy Horse, Karagam & Kavadi and Periya Melam from Tamil Nadu, Mathuri, Lambadi & Dhimsa from Telangana, Garagalu from Andhra Pradesh, Kaaliyattam of Puducherry, Thiruvthirakali from Kerala, Veeragasi, from Karnataka were presented.

May 2016

Programmes were presented in Summer Festival arranged in various parts of Tamil Nadu. Thudumbattam, Dollukunitha, Goravayulu, Mathuri & Bonalu, Thappattam, Kuchipudi and Mohiniyattam were performed. The Centre has also participated in the Mega Cultural Festival held at Jawahar Public School, Edava, Kerala. Artforms viz. Dummy Horse, Karagam, Kavadi, Bhangra, Sambalpuri, Veerakasi, Garagalu were performed during the festival.

June 2016

SZCC has organized National Terracotta Workshop in the premises of SZCC. 27 Terracotta Crafts Artisans from various places from India participated.

International Yoga Day

SZCC has arranged the Yoga Training on the occasion of International Yoga Day at Thanjavur. SZCC also organized International Yoga Day at Madurai, Tamil Nadu and Davangere, Karnataka.

Programmes were presented in Summer Festival held at Salem, Cuddalore and Elagiri, Tamil Nadu. Dollukunitha, Mathuri, Thappattam, Kalkol Attam, Kuchipudi and Bharathanatyam were performed.

July 2016

SZCC participated in the Birth Anniversary Celebration of Poet Vanidasan held in Puducherry and in Book Festival held at Thanjavur. Art forms viz., Thappattam, Therukoothu, Thudumbattam, Devarattam, Karagam and Kavadi were presented during the festival.

August 2016

SZCC presented Kuchipudi, Kalbelia and Bihu dances during the Independence Day celebrations held in Raj Bhavan, Chennai and also participated in World Folklore Day held at Bangalore, Karnataka and presented folk artforms viz., Dummy Horse, Karagam, Kavadi, Kolkali and Lambadi.

SZCC in collaboration with Film Division organized Film Festival in its premises. 14 Nos. of Short Films were screened during the Film Festival. More than 1000 school children witnessed and enjoyed the programmes.

South Zone Cultural Centre actively participated in Fete-De-Puducherry a major cultural event of Puducherry organized by the Government of Puducherry. This festival was conducted at Puducherry (in 8 Rural Areas) Karaikal and Yanam from 14th to 18th of August 2016 coinciding with the “De Jure Day” Celebrations. 4 troupes from Northern Zone and 1 troupe from North East, 9 troupes from Member States and 57 Folk, Music, Classical Dance and Drama troupes from Puducherry and Karaikal Areas have participated in this Mega Cultural Festival.

The festival was conducted at Thanjavur, Kallanai,Manora, Vaduvur, BHEL and Anakarai. Around 65 Folk, Tribal, Drama and Classical troupes from several states of the Country consisting of more than 1000 Artistes have participated. Around 128 Handicrafts were exhibited.

SZCC has participated in the All India Arts & Crafts Mela 2016 held at Shilparamam, Telangana. Artforms Sambalpuri, Mathuri, Karagam & Kavadi, Singari Melam, Thadiya Chaufala, Porparai, Chakka Bhajana were presented.

SZCC has presented folk art forms viz. Sirmori Natti, Teratali, Sambalpuri in the Indian Dance Festival held at Mamallapuram, Tamil Nadu.

SZCC participated in the Rashtriya Sanskriti Mahotsav in Varanasi, Uttar Pradesh organized by the Ministry of Culture, Government of India where art forms viz., Kalaripayattu, Dollu Kunitha were performed.

Jashn- E- Kashmir

Programmes of art forms from Jammu & Kashmir were organized at various venues in Kerala, Tamil Nadu in the month of February and March.2017.

Octave 2017

A Festival of art forms from North Eastern states was organized in Puducherry, Tamil Nadu and Telangana. 13 Art forms from North East participated in Puducherry and 10 art forms have participated in Tamil Nadu and Telangana held during 24th February and 3rd March 2017.

March 2017

The South Zone Cultural Centre has organized Rashtriya Sanskriti Mahotsav at Kalagaram, Bangalore from 5.3.2017 to 8.3.2017. Apart from the main venue, programmes were organized in 6 outreach places. Around 30 Folk troupes from all over India/UTs 432 Artistes, 38 Crafts and 3 Food Crafts (68 artisans) have participated. 5000 people witnessed and enjoyed the programme daily. On the last day i.e. 8th March, being the International Women's day more than 350 WomenFolk and Tribal artistes from Karnataka participated in this festival.

National Tribal Festival was organized in Madikeri, Karnataka. 20 Tribal troupes from Karnataka, 7 troupes from other parts of India consisting of 346 artistes have participated in this festival.

SZCC has organized Thanjavur Traditional Painting Camp in its Premises. 21 Eminent Artists from Tamil Nadu have participated.

Historical, Social and traditional Dramas viz. Chavittu Natakam of Kerala, Veedhi Natakam of Telangana and Therukoothu of Tamil Nadu were staged by SZCC during the National Drama Festival held at Puducherry.

Ugadi Festival in Telangana & New Delhi

AUDITORS REPORT

We have audited the annexed balance sheet of the "SOUTH ZONE CULTURAL CENTRE, THANJAVUR, as on 31st March, 2017 and also the annexed Income & Expenditure account and Receipts and Payments account for the year ended 31st March, 2017 which have been prepared by the management of South Zone Cultural Centre, Thanjavur.

The preparation of the financial statements is the responsibility of the management of South Zone Cultural Centre, Thanjavur. Our responsibility is to express an opinion on the financial statements based on our audit.

We have conducted the audit in accordance with the generally accepted auditing standards. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatement. An audit includes examining on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used by the management, as well as evaluating the overall financial statement presentation. We believe that our audit provides a reasonable basis for our opinion.

1. Proper books of accounts as is considered necessary for the purpose of audit have been maintained by the South Zone Cultural Centre, Thanjavur.
2. The Receipts and Payments account referred to above is in agreement with the books of accounts.
3. According to the information and explanations given to us, the expenses have been adequately authorized.
4. The payment of Gratuity Act is applicable to the Centre and it is obligatory to pay gratuity on to the zonal staffs that have put in 5 year of continuous service at the time of retirement, resignation or death. In respect of post retirement benefit viz. gratuity as per accounting standard 15 issued by the institute of chartered accountants of India, the centre should make provision on actuarial basis every year towards liability for future payment at gratuity. However during the year provision for gratuity has been made on ad hoc basis to the tune of Rs.18 lacs only. Such creation of provision is not in accordance with the accounting standard. It is advised that the Centre should get an actuarial valuation and make further provisions.

MANAGEMENT LETTER FOR THE YEAR ENDED 31.03.2017

1. South Zone Cultural Centre is a Society Registered under the Tamil Nadu Societies Registration Act, 1975.
2. South Zone Cultural Centre is Registered under Section 12A (a) of the Income Tax Act and is filling its returns of Income with the Income Tax Authorities.
3. According to Section 11 of the Income Tax Act the Society has to spend not less than 85% of its Income of a year in that year itself and the same has not been complied with during the year ended 31.03.2017.

Grants Received from Government of India:

The Centre have received grants from Government of India in the categories namely, Plan - ZCC, NER and TSP programmes during the financial year ended 31.03.2017. Additional funds were provided for conducting Rashtriya Sanskriti Mahotsao (RSM).

Program Advance:

Advances issued for conducting various programmes as per Annexure - 1 at the beginning of the financial year was Rs.14894188/-. Fresh Advance of Rs.20050326/- were issued and a sum of Rs.18134508/- were adjusted/recovered during the year and the balance out standing at the end of the year was Rs.16810006. Effective steps should be taken for easily settlement of these advances.

Even though almost all the programmes for which the above advances were issued were already conducted and the advances amounts spent, since the authorities/staff members to whom the advances were given had not settled the accounts, the expenditures out of these advances had not been brought to accounts. As a result, the excess of expenditure incurred over the income shown in the Income and Expenditure account were under stated and the surplus shown in the Balance Sheet were over stated to the extend of expenditure incurred out of these advances.

Gratuity Provision:

The payment of Gratuity Act is applicable to the Centre and it is obligatory to pay gratuity on to the zonal staff who have put in 5 year of continuous service at the time of retirement, resignation or death. In respect of post retirement benefit viz gratuity as per accounting standard 15 issued by the chartered accountants of India, the centre should make provision on actuarial basis every year towards liability for future payment of gratuity. However during the year provision for gratuity has been made on ad hoc basis to the tune of Rs.18 lacs. It is advised that the Centre should get an actuarial valuation and make further provisions.



Interest on FD:

During the verification of records we observed that Interest on Fixed Deposit relating to Indian Bank amounting to Rs.46875 (Third Quarter) has not been received .The centre should take necessary steps to recover the same.

Statutory Compliance:

During the audit of records we found that TDS was not paid with in due date. The centre should take necessary steps to ensure all the statutory payments are made with in due date.







Significant Accounting Policies

- 1) The accounts have been prepared under the Historical cost convention unless otherwise stated and on the accrual method of accounting.
- 2) Being a not for profit organization, revenues in the form of grants from various institutions and Government agencies are recognized as and when the same is received. Accounting of receipt of Grants complies with the Accounting Standard 12 prescribed by ICAI.
- 3) Fixed Assets are stated at written down value after providing depreciation at the rate provided in the Income tax Act 1961.
- 4) Investments are stated at cost and interest accrued on the same has been considered up to the end of the financial year.
- 5) Fixed Assets and other deposits value amounting to Rs.72,56,285/- relating to Shilparamam Craft Village - Hyderabad are transferred to Andhra Pradesh Government account and shown as current receivable. The decision of getting back the above amount from the State of Andhra Pradesh or State of Telangana is to be confirmed by the Executive Board.
- 6) Expenses identifiable with specific grants are allocated and accounted separately as per Accounting Standard 12 prescribed by ICAI.
- 7) Expenses not allocable to any specific grant has been accounted commonly complies with Accounting Standard 12 prescribed by ICAI.
- 8) Unspent balance of Grants are carried forward to subsequent years and are shown under Advances and deposits.



SCHEDULE - 25

Notes on Accounts

1) Corpus/Capital Fund - Schedule 1

The SZCC has to receive a sum of Rs.300 lakhs from the member states towards additional corpus contribution as per the GOI letter dated 06.11.2012.

2) Reserves & Surplus - Schedule 2

Reserves & Surplus includes "Capital Reserve" of Rs.169.00 lakhs brought forward from the previous financial year. Accrual to the general reserve for the year being Rs. 439.42lakhs.

3) Earmarked/Endowment Funds - Schedule 3

During the year SZCC has not received fresh infusion of fund on this account.

4) Current Liabilities & Provisions - Schedule 7

Current Liabilities of Rs.59.35lakhs includes Rs.35.18lakhs on account of provisions made to various expenses.

Liability towards gratuity payable of employees is not fully provided.

5) Fixed Assets - Schedule 8

- a) Buildings values of Rs.71.00lakhs relating to Shilpramam Craft Village - Hyderabad are to be transferred to Andhra Pradesh Government after receipt of the amount by SZCC from Andhra Pradesh Government. However, symbolically the amount to be received from the State of Andhra Pradesh is currently shown in the receivables a/c.
- b) Fixed Assets are stated at written down value after providing depreciation at the rate provided in the Income tax Act 1961. Fixed assets received by way of non - monetary grants are capitalized as per Accounting Standard 12 prescribed by ICAI.
- c) Depreciation has been provided on written down value method as per rates specified in the Income Tax Act 1961.



- d) Excess depreciation on Buildings has been provided last year now rectified as per the direction /comment given by CAG.
- e) Rs.4003 has been reduced from furniture and fittings for loss of ladder.
- f) Various art forms, traditions are recorded and documented in CDs/DVDs/Cassettes and preserved in the library of this centre. Earlier the same was classified under furniture and fittings, now the same has been classified as library books and provided depreciation at the rate of 60% as per the direction/comment given by CAG. Similarly L.C.D Projector was included in Furniture and Fittings now reclassified as Machinery head and provided depreciation at 15%.
- g) SZCC has not acquired any asset under hire purchased during the year.

6) Investments - Others - Schedule 10

Investments are carried at cost. Investment of Rs.3506.57 lakhs are made in scheduled banks and in Government of Tamilnadu undertakings.

7) Current Assets, Loans & Advances- Schedule 11

Current Assets of Rs.1282.91 lakhs includes, Rs.1.53 lakhs relating to Shilparamam Craft Village -Hyderabad are to be transferred to Andhra Pradesh Government after receipt of the amount by SZCC to Andhra Pradesh Government.

8) Contingent Liabilities

There exists no known liability of Contingent nature during the financial year ending 31.3.2017.

Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of the South Zone Cultural Centre, Thanjavur for the year ended 31 March 2017.

We have audited the attached Balance Sheet of the South Zone Cultural Centre, Thanjavur as at 31 March 2017, Income & Expenditure Account and Receipts & Payments Account for the year ended on that date, under Section 20 (1) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) Act, 1971. The audit has been entrusted for the period up to 2019-20. These financial statements are the responsibility of the Authority's management. Our responsibility is to express an opinion on these financial statements based on our audit.

2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards, disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the law, Rules & Regulations (Propriety and Regularity) and efficiency-cum performance aspects, etc., if any, are reported through Inspection Report/ CAG's Audit Reports separately.

3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material mis-statements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statement. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4. Based on our audit, we report that:

- i We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.
- ii The Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report have been drawn up in the format approved by the Ministry of Finance except with regard to comments in Para D (i).
- iii In our opinion, proper books of accounts and other relevant records have been maintained by the South Zone Cultural Centre, Thanjavur as required in the rules and regulations of the institute, in so far as it appears from our examination of such books subject to the comments mentioned below.

iv We further report that:

A. Balance Sheet

Liabilities – Corpus/Capital Fund (Sch.1) – Rs.29,50,00,000.

Earmarked/Endowment Funds (Sch.3) – Building Fund – Rs.2,30,76,743.

The building fund amounting to Rs.2,30,76,743 received from GoTN in 1990-91 for creation of infrastructure has been utilised for construction of institute building. However, the fund has been wrongly continued to be disclosed as earmarked fund under liabilities. Since, the fund has been utilised and asset has been created out of the fund, as per the guidelines in uniform format, this amount should have been transferred to capital fund. Non compliance of guidelines has resulted in overstatement of earmarked fund and understatement of capital fund to the extent of Rs.2.31 crore.

B. Income & Expenditure Account

Income – Grants/subsidies (Sch.13) – Rs.12,86,77,000

Balance Sheet

Liabilities – Current Liabilities and Provisions (Sch-7) – Rs.59,35,165

Accounting of entire grant received during the year amounting to Rs. 12,86,77,000 as income in income & expenditure account, without considering the actual expenditure incurred out of grants to the extent of Rs. 8,87,96,209, has resulted in overstatement of income and surplus in I&E account to the extent of Rs.3,98,80,791. Consequently, this has resulted in overstatement of Reserves and Surplus and understatement of current liabilities (unutilised grant) to the extent of Rs.3.99 crore.

C. Accounting Policies

According to the uniform format for financial statements, the accounting policies adopted by the institute in preparation of financial statements have to be included in the 'significant accounting policies and notes on accounts' schedule enclosed to the financial statements. However, the institute has not included the accounting policies adopted for accounting of government grants, retirement benefits, depreciation on assets not put to use for full year, excess expenditure incurred on various programmes over and above the advances, interest earned on corpus fund investments and earmarked fund deposits, transfer of surplus in I&E account to general reserve, valuation and accounting of artefacts, pictures and sculptures held by the institute, in the significant accounting policies schedule (sch-14) enclosed to the financial statements.

This comment was included in last year separate audit report also. However, no action has been taken by the institute.

D. General

i) The actual cost of the fixed assets held by the institute has not been disclosed under 'Gross block' of the fixed assets schedule (Sch-8) as required by the uniform format of accounts. The net asset value arrived after adjusting the depreciation of earlier year was incorrectly disclosed as gross block value. Similarly, the depreciation block in the schedule is not disclosing the total depreciation provided till last year.

This comment was included in last year separate audit report also. However, no action has been taken by the institute.

ii) The correctness of an amount of Rs.50,388/- shown as 'suspense' under current liabilities (Sch-7) could not be ensured by Audit.

iii) In notes on accounts (Sch-25 – Para.1) enclosed to financial statements, the amount receivable from member states towards corpus contribution has been incorrectly mentioned as Rs.300 lakhs instead of Rs.450 lakhs.

iv) No confirmation of balances was furnished for an amount of Rs. 1,68,10,006 and Rs. 5,66,924 disclosed as prepayments and deposits respectively under loans and advances in balance sheet. As some of these advances were lying unadjusted for more than sixteen years, the correctness of the same could not be ensured by Audit. This comment was included in last year separate audit report also. However, no action has been taken by the institute.

E. Grants in aid

Out of the grant-in-aid of Rs 12.87 crore received for the year, the Centre utilized a sum of Rs.8.88 crore, leaving a balance of Rs.3.99 crore.

v Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income & Expenditure Account and Receipts & Payments Account dealt with by this report are in agreement with the books of accounts.

vi In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Accounts, and subject to the significant matters stated above and other matters mentioned in the Annexure to this Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India.

a. In so far as it relates to the Balance Sheet, of the state of affairs of South Zone Cultural Centre, Thanjavur as at 31 March 2017; and

- b. In so far as it relates to Income & Expenditure Account of the surplus for the year ended on that date.
