**Subject: Setting up of various Committees under Scheme "National Mission on Cultural Mapping and Roadmap".**

With approval of the Competent Authority, following Committees are set up under the Scheme "National Mission on Cultural Mapping and Roadmap":-

**(1) Apex Committee:-**

**(a) Composition:**

**(b) Powers and Functions of Apex Committee:-**

- (i) Over-all policy making, giving the direction for the Mission
- (ii) Framing of guidelines
- (iii) Nomination of members & experts on the Project Approval Board
- (iv) Strategy formulation & mid-course corrections
- (v) Periodic review of outcomes and general monitoring of the Mission as a whole

- (vi) Coordination between various Central Ministries and between Centre, States and NGOs etc.
- (vii) Addition/alteration of powers and functions of any Committee or Authority under this Mission
- (viii) Decisions regarding delegation of power (Financial or otherwise) to various Committees/ Authorities/Functionaries involved in the Mission or its projects.

**(2) Empowered Experts Committee (also known as Project Approval Board):-**

**(a) Composition:**

- (i) Secretary, Ministry of Culture - Chairperson
- (ii) Eminent experts from Cultural organisations and Individual artist experts - Members
- (iii) Representative from Department of Expenditure, NITI AAYOG, Ministry of Panchayati Raj, Department of Telecommunications, Ministry of Electronics and Information Technology (MeitY), Department of Space, Department of Rural Development, Ministry of Tribal Affairs, Ministry of Minority Affairs, ICCR, Ministry of Textile, Ministry of Information & Broadcasting, Ministry of Skill Development & Entrepreneurship - Members
- (iv) Representatives from State Governments - Members
- (v) Joint Secretary & head of the Mission Secretariat, Ministry of Culture - Member Secretary

**(b) Powers and Functions of Empowered Experts Committee:**

- (i) Critical appraisal and sanctioning of various project proposals under the Mission based on the Detailed Project Reports (DPRs)
- (ii) Making recommendations to the Apex Committee on matters of importance
- (iii) Final negotiations/deliberations on Intellectual Property Rights(IPR)/copyright related issues
- (iv) Selection of Domain Expert Committee and Programme Advisory Committee of the Mission
- (v) Promotion of any activity interest of the spirit of Mission
- (vi) Management and funding
- (vii) Network of Experts/Institutes/Industry-Institute/any network useful for the Mission in various fields
- (viii) Deliberating on the Powers and Functions of various Committees

2. The tenure of aforesaid Committees shall be co-terminus with the period of the aforesaid Scheme.


3. **Meetings:** The meetings of above Committees shall be held from time to time as per need/requirement.

4. **TA/DA/Sitting fee etc.:** The admissibility of TA/Conveyance Charges/Sitting fee/Hotel Accommodation Charges etc. in respect of Non-official Members shall be as per extant rules applicable in their cases and expenditure in this regard will be borne by CCRT, New Delhi. In case of Official Members, the admissibility of TA etc. shall be governed by respective service rules applicable in their case and expenditure will be borne by their respective offices.
