

Minutes of the Meeting to Review data Collection from Akademies
Under The Scheme “National Mission on Cultural Mapping And Roadmap”,
Held on 29.06.2018 at JS Office, IGNCA, New Delhi.

i) For a one month period (July- August, 2018), akademies may get their paper data ready and employ one or two Data Entry Operator (DEO) through NIC empanelled list of DEOs.
