Tender Notice

Subject: Annual Rate Contract for printing of Letter Heads/D.O. Letter Heads, Visiting Cards and other printing items for use in Ministry of Culture – reg.

Sealed tenders are invited in a two bid system for Annual Rate Contract (ARC) for printing of various stationary items etc. as per Annexure-I for use in the Ministry of Culture. The initial contract would be for a period of one year which may be extended for a further period of two years, one year at a time on the basis of satisfactory performance of the firm and mutual willingness of both parties.

- 2. The bid shall consist of two parts Technical Bid and Financial Bid. Both the bids are to be placed in two separate sealed envelopes (clearly subscribing 'Technical Bid' and 'Financial Bid') which in turn are to be placed in a separate sealed cover clearly subscribing 'Bid for Annual Rate Contract for Printing of various items for use in the Ministry of Culture. The financial bids of only those parties shall be opened whose technical bids are found to be eligible.
- 3. Terms and conditions:-
- (a) GST Number (a self attested copy of GST Number);
- (b) PAN Number (a self attested copy of PAN No. card shall be furnished);
- (c) The bidder should have 3 years experience in the field of printing various stationery items in the Government Departments/Ministries;
- (e) The firm should furnish details of three (3) current Annual Maintenance Contracts for the printing of various stationery items in the Ministries/Departments. A satisfactory performance report/from each of the Department for the contract shall also be enclosed;
- (f) The firm should have annual turnover of Rs. 5 lakhs during the last three years. The firm should furnish a Balance Sheet duly audited and certified by Chartered Accountant towards proof of average annual turnover and Income Tax Returns for the last three financial years;
- (g) Undertaking from the firm that it has not been debarred or blacklisted by any of the Central/state Government/ Departments/ Organizations/Central PSUs and no criminal case is pending/filed against the said firm/proprietor.
- 4. Earnest Money Deposit (Bid Security) Those firms who are interested to bid shall furnish an earnest money deposit of Rs. 5000/- in favour of "DDO, Ministry of Culture, Shastri Bhawan, New Delhi" as Demand draft / Bankers cheque/ Fixed deposit receipt (FDR). Tenders with no earnest money deposit will be summarily rejected.
- 5. Performance Security: The Performance Security of Rs. 15000/ (Rupees fifteen thousand only) shall be deposited by the tenderers within 7 days of the award of Contract in the form of Fixed Deposit Receipt in favour of "DDO, Ministry of Culture, Shastri Bhawan, New Delhi. In case of non submission of Performance Guarantee within stipulated period, the earnest money will be forfeited and the Ministry may consider to debar/black list the successful bidder.



- 6. General Terms and Conditions:
- The bidders are cautioned that supply for incomplete information called for in the application forms or deliberate suppression of any information may result in the bid being summarily disqualified. Bids received after the expiry of the stipulated date and time mentioned in the tender document will not be accepted.
- Overwriting should be avoided. Correction, if any, should be made by neatly crossing out, signing with date and rewriting. Pages of the eligibility criteria document are to be numbered. Additional sheets, if any added by the bidder, should also be numbered.
- 6.3 The Ministry shall provide bench mark/quality/brand of the material to be used, where ever necessary. In case the work is not executed within the specified time frame, the Ministry will be free to get the work done through alternative sources and the additional cost incurred on the same shall be recovered from the firm.
- The defective printing material, if any supplied by the firm, shall be replaced by the supplier at his own cost. However, in case of defective supply of printed material on more than 3 occasions the contract shall be cancelled and security deposit shall be forfeited. The firm may also be debarred by this Ministry.
- 6.5 In the event of any dispute related to above, the decision of competent authority in Ministry of Culture shall be final and will be binding on all Vendors.
- 6.6 TDS and other taxes as applicable shall be deducted from each bill.
- 7. Interested firms/parties having met the aforesaid eligibility criterion and accepted terms and conditions may send their quotations in sealed covers superscribed with the words "Quotations for printing of various items for use in Ministry of Culture". The quotation should be addressed to the undersigned. Sealed Tenders may be dropped in the Tender Box placed in Room No. 330, C Wing, Shastri Bhawan, New Delhi latest by 3:00 PM on 14th August, 2017. The tenders will be opened on same day at 3:30 PM in the presence of tenderers or their authorized representatives. The Tender Committee will assess the ability of the agencies based on its record, profile and on such other criteria as per technical bids. The representatives of only those found successful at the technical bid stage would be allowed to be present at the time of opening of financial bids.


