The expenditure will be met from Demand No.18-Ministry of Culture, Major Head '2205' Art & Culture Minor Head <u>00.789.02.01.31</u> under the "<u>Kala Sanskriti Vikas Yojana</u> (<u>Schemes and Missions</u>)" Grant-in-aid-- General <u>2019-2020</u> (Non recurring)/SCSP for the financial year <u>2019-2020</u>.
