- 2. The expenditure will be met from Demand No.17-Ministry of Culture, Major Head '2205' Minor Head <u>00.789.02.01.31</u> Scheme "Kala Sanskriti Vikas Yojana (Schemes and Missions)" Grantin-aid <u>2021-2022 (Non-recurring)/SCSP</u> for the financial year <u>2021-2022</u>.
