2. The expenditure will be met from Demand No.18-Ministry of Culture, Major Head `2205' Minor Head **00.789.02.01.31** Scheme **"Kala Sanskriti Vikas Yojana (Schemes and Missions)"** Grant-in-aid **2022-2023 (Non-recurring)/SCSP** for the financial year **2022-2023**.

- 3. The grant will be drawn by the Drawing & Disbursing Officer (Grants), Ministry of Culture and paid to the organization by means of RTGS.
