- 2. The expenditure will be met from Demand No.17-Ministry of Culture, Major Head '2205' Minor Head **00.789.02.01.31** Scheme **"Kala Sanskriti Vikas Yojana (Schemes and Missions)"** Grant-in-aid **2021-2022 (Non-recurring)/SCSP** for the financial year **2021-2022**.
- 3. The grant will be drawn by the Drawing & Disbursing Officer (Grants), Ministry of Culture and paid to the organization by means of RTGS.
- 4. This is non-recurring grant in nature and it is being released after fulfilling the conditions prescribed in GFR Rule.
