

- 2. The expenditure will be met from Demand No.18-Ministry of Culture, Major Head '2205' Minor Head <u>00.789.02.01.31 Scheme "Kala Sanskriti Vikas Yojana (Schemes and Missions)"</u> Grant-in-aid 2023-2024 (Reimbursement Mode)/SCSP. for the financial year <u>2023-2024</u>.
