



** As per scheme guideline of CFGS maximum grant is upto Rupees 5 Lakh (in normal cases)/ Rs. 20 lakh (in exceptional cases) or 75% of total expenditure incurred by organization, whichever is less, therefore the grant has been restricted to 75%.


- The expenditure will be met from Demand No.18-Ministry of Culture Major Head '2205' Minor Head 00.102.11.01.31 Scheme "Kala Sanskriti Vikas Yojana (Schemes and Missions)" Grant-in-aid 2024-2025 (Non-recurring) GIA-General for the financial year 2024-2025.
- The grant will be paid to the grantee organization by means of electronic transfer.
- This is non-recurring grant in nature and it is being released after fulfilling the conditions prescribed in GFR Rule. The accounts of all grantee institutions or organizations shall be open to inspection by the sanctioning authority and audit both by the Comptroller & Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by the Principal Accounts Office of the Ministry whenever the organizations is called upon to do so.
- As the grant is being released as reimbursement of expenditure already incurred on the basis of the Audited Statement of Accounts and utilization Certificate duly signed by the Chartered Accountant the Utilization Certificate will not be necessary.
- No Utilization Certificate is pending in respect of earlier grant. No unspent balance is pending for earlier grant.
- The Utilization Certificate in respect of the previous grant sanctioned to the grantee (First Instalment) has been issued (copies enclosed)
- No other bill for the same purpose and instalment has already been paid before to the grantee.
- It is certified that the targets in quantified and qualitative terms that the grantee was required to achieve have been achieved.
- The Grant-in-aid is further subject to the conditions laid down in GFR as amended for time to time.
- This issues under the enhanced financial powers delegated to the Ministry. It is certified that the pattern of assistance under the Scheme mentioned above has the prior approval of the Ministry of Finance Government of India. It is also certified that the grant is being released in conformity with the rules and principles of the Scheme. This issue with the approval of IFD vides their Dy. No.64437. Dated. 24/09/2024.
