

\*\*As per scheme guideline of CFPG maximum grant is upto Rupees 5 Lakh (in normal cases)/Rs. 20 lakh (in exceptional cases ) or 75% of total expenditure incurred by organization, whichever is less, therefore the grant has been restricted to 75%.

2. The expenditure will be met from Demand No.18-Ministry of Culture Major Head '2205' Minor Head 00.102.11.01.31 Scheme "Kala Sanskriti Vikas Yojana (Schemes and Missions)" Grant-in-aid 2024-2025 GIA-General for the financial year 2024-2025.

3. The grant will be paid to the grantee organization by means of electronic transfer.


4. This is non-recurring grant in nature and it is being released after fulfilling the conditions prescribed in GFR Rule.
