I am directed to convey the sanction of the President of India for authorizing financial assistance approved under Guru-Shishya Parampara (Repertory Grant) scheme through National School of Drama, New Delhi i.e. designated CNA for the scheme in respect of 05 grantee organizations approved under Renewal category for grant year 2021-22 amounting to **Rs.32,28,000/- (Rupees Twenty Two Lakh Twenty Eight Thousand Only)** in respect of **05 Guru @Rs.10,000/- per month and 36 Artists @ Rs.6,000/- per month** for the period w.e.f. 01.04.2021 to 31.03.2022 and 06 enhanced artists for 02 organizations as per details given below:-

2. The above said financial assistance may be disbursed to subsidiary agencies (grantee organizations) through Central Nodal Agency (CNA) following the terms and instructions mentioned in Sanction letter Para 3 and Para 4 of Sanction order vide which amount for authorizations are being released to CNA. The assignment limit to the sub agencies i.e. Repertory Organizations may be authorized by the CNA as per limit indicated in column 9 of the table in para 1, so that the sub-agencies/child agencies can draw the funds as per assigned limit.

3. The sub-agencies may be instructed to use electronic payment filing facility available in PFMS System for making payment to Guru and Shishyas under the scheme as per extant rules.

4. This said financial assistance is issued in exercise of the delegated powers in consultation with Integrated Finance Division (IFD), Ministry of Culture as concurrence conveyed for the expenditure vide their Dy. No. 64728 dated 07.03.2025.

5. The funds for incurring the above said expenditure has already been released to NSD's Account in current financial year.

1. The President/Secretary to the above-mentioned Cultural Organizations with the following instructions:-

(A) It may be noted that the request of repertory grant for the year 2024-25 will be considered only on receipt of the following documents to the Director, National School of Drama, Bahawalpur House, Mandi House, New Delhi-110001(if already the requisite documents have been sent to NSD, New Delhi, ignore it):-

(i) A report on activities of the Organization during the year 2023-2024 (ii) Activities proposed/Action Plan for the year 2024-2025 (iii) Justification for renewal of assistance for the year 2024-2025.

(B) It may also be noted that the following documents are also to be furnished mandatorily on receipt of this grant to the Director, National School of Drama, Bahawalpur House, Mandi House, New Delhi-110001 as required under the condition attached to the sanction herein above:-

(i) Audited balance sheet, Income & expenditure statement and receipt & payment statement, covering all the activities of the organization, for the year 2021-22 (ii) Audited payment-receipt accounts specified to the grant under the scheme for the year 2021-22 (iii) Utilization Certificate in GFR 12-A format as prescribed in General Financial Rules, 2017 issued by a Chartered Accountant on his letter head and counter signed by the organization, in respect of the grant for the year 2021-22 (iv) Details of payment made out of the grant for 2021-22 (v) Proof of having staged at least two productions during the year 2022-2023 out of which at least one production must be a new production i.e. one which has not been staged earlier (vi) A Bond in the prescribed proforma with two Sureties to the President (vii) A resolution duly passed by the executive committee/Board of the Institution and (viii) A duly filled in & signed Bank proforma/Authorization letter verified & signed by the Manager of your Bank (ix) A copy of Sanction Letter for the financial year 2021-22. (x) Mandatory Conditions/requirements:-

(a) The organization should organize at least 02 activities (function, lecture, seminar, workshop, exhibition etc.) in any of the schools in their vicinity. A certificate to this effect from the principal of schools would be a mandatory requirement for Renewal of Repertory Grant.

(b) For compliance of Direct Benefit Transfer (DBT), furnish the DBT details in the prescribed excel format in Annexure-II which is available on the website of the Ministry [Link-<http://www.indiaculture.nic.in/important-informationnotices-grantee-organisations-pags>] and send the duly filled up downloadable Annexure-II (in excel format) on official email id of P.Arts-I Section: parts1-culture@gov.in within 15 days from issue of this sanction order (if not sent earlier).

(c) The U.C. in GFR 12-A format (as prescribed under General Financial Rules, 2017) to be uploaded on PFMS Portal (after getting it signed by Chartered Accountant) & also a copy of it is to be submitted by the grantee organization to National School of Drama, Delhi within twelve months of the closure of the financial year in which the sanction was issued, otherwise, they will be considered as blacklisted and debarred for receiving any future financial assistance.
