

Minutes of the meeting of Steering Committee held on 07.9.2021 under the Scheme Component of 'Financial Assistance to Cultural Organizations with National Presence' under "Scheme of Financial Assistance for Promotion of Art & Culture" for the year 2020-2021.

A meeting of the Steering Committee was held on 07.09.2021 from 01.30 PM onwards under the Chairpersonship of Smt Vidyavathi Vaidyanathan, Director General, Archeological Survey of India at Dharohar Bhawan, 24 Tilak Marg, New Delhi to examine the proposals in detail and to decide the quantum of financial assistance to deserving organizations under the scheme component of 'Financial Assistance to Cultural Organizations with National Presence' for the year 2020-2021. The following Members attended the meeting:-

- (i) Smt. Vidyavathi Vaidyanathan, Director General (Archeological Survey of India), & Chairperson ;
- (ii) Ms. Amita Prasad Sarbhai, Joint Secretary (P. Arts Bureau), MoC & Member;
- (iii) Ms. Deepika Pokharna, Director (P. Arts), MoC & Member Secretary;
- (iv) Shri Harish Kumar, Director (Finance) & Member (Representative of JS & FA, MoC);
- (v) Shri Dinesh Khanna, Director In-charge (National School of Drama) & Member;
- (vi) Smt. Renu Singh, Deputy Secretary (Akademies), MoC & Member; and
- (vii) Ms. Helen Acharya, Deputy Secretary (Sangeet Natak Academy) & Member.

2. At the outset Ms. Amita Prasad Sarbhai, JS (P. Arts Bureau), MoC welcomed Chairperson and all the members of the Committee and gave a brief outline of the Scheme component, eligibility criteria and its relevant guidelines.

3. The Committee then examined the proposals submitted by the organizations, taking into account the profile of the organization, subject of proposed project, duration of the project, estimated cost of the project and amount sought from the Ministry. Further, expenditure done by the organization/trust on cultural activities during three years out of the last five years and activities undertaken by the organization.

4. Out of 86 proposals received in response to the advertisement; 66 were received by the last date of receipt of application i.e. 9th November, 2020. The proposals received after due date were also put up before the Steering Committee but were not considered by the Committee. Analysis and recommendations of the Committee are as under:-

5. While deciding the financial assistance to the eligible organizations, the Committee took into consideration the criterion laid in the scheme guidelines such as whether the organization has spent Rs.1 crore or more during three of the last five years on cultural activities, the organization has capacity to do at least 20 events/programmes in a year, etc. The committee also noted that many applicant organizations were already existing recipients of grants such as Repertory Grant, Cultural Function & Production Grant, etc. administered by the Ministry of Culture. The Committee further noted that the project brief as well as estimated cost of few of the organizations were similar to each other.

6. The Committee after deliberation and due consideration of the documents submitted by the applicants and after taking into account other eligibility criteria recommends the financial assistance to the under-mentioned four (04) organizations as per details given below:-


