1. Prequalification Criteria:

The Bidder should have executed on his own or through a consortium (Lead Member shall be of Electrical Contractor/firm), the following works for meeting the bid evaluation criteria failing which the offer shall not be further evaluation:

In case of Bid of Sole Bidder:

- a. The firm should be Original Manufacturer of High Sensible Package AC Units or authorized by manufacturer for carrying out the above work. A proof to this effect must be submitted along with PQ Application.
- b. The contractor/firm should be registered with CPWD in electrical mechanical/composite category in class-B or above and have valid Class A electrical contractor license in the firm name.
- c. The contractor/firm must have an experience of similar services i.e. SITC of Environmental works comprising of Air conditioning, ventilation, air cooling, electrical works etc. The firm should have minimum ten years experience in the line.
- d. The bidder should have satisfactorily completed at least two similar works value of Rs. 50 Lac each in government sector during the preceding 7 Years, reckoned from the due date of submission of PQ Application. (Similar Works Means High Sensible/Precision type Air conditioning work of 60 TR Capacity in single order along with electrical works etc)
- e. Average turnover should be at least Rs 50 Lac during immediate three consecutive financial years. The firm shall attach CA turnover certificate.
- f. Net Worth of the firm should be at least 60 Lacs.

- g. Should have on their rolls, adequate licensed personnel as required under I.E. act for carrying out work on electric panels and related electrical works.
- h. The firm should submit copy of VAT, ST, ESI, PF Registration certificate.
- i. The firm shall attached copy of PAN No with the PQ application.

In case of Consortium Bids

- a) The Lead member/firm should be Original Manufacturer of High Sensible Package AC Units or authorized by manufacturer for carrying out the above work. A proof to this effect must be submitted along with PQ Application.
- b) The Lead Member/contractor should be registered with CPWD in electrical mechanical/composite category in class-B or above and have valid Class A electrical contractor license in the lead member/firm's name.
- c) The lead member of consortium shall be a firm/contractor of his own having experience in either electrical or HVAC. The overall project management shall be performed by the leader. The members of consortium shall assume responsibility jointly and severally. The lead member shall submit Consortium Agreement/MOU along with the bid clearly defining the scope and responsibility of each member. This Agreement/MOU must remain in force till the pendency of this contract. The selected leader of the consortium shall be authorized to incur liabilities and receive instruction for and on behalf of Consortium. The Lead member shall be sole responsible for the work and work shall be awarded in their name.
- d) The lead member should have satisfactorily completed at least any of work pertains to Electrical Mechanical Jobs of value not less than Rs. 50 Lac in government sector during the preceding 7 Years, reckoned from the due date of submission of PQ Application.

j. The 2nd leader should have satisfactorily completed at least one similar works value of Rs. 50 Lac each in government sector during the preceding 7 Years, reckoned from the due date of submission of PQ Application. (Similar Works Means High Sensible/Precision type Air conditioning work of 60 TR Capacity in single order along with electrical works etc)

(Note The completion certificate for the work shall be signed by an officer not below the rank of Executive Engineer. The Completion Certificate shall clearly indicate name of work with value and details of system, type and capacity of equipments and the date of completion of work and shall be furnished along with the tender document).

- e) Average turnover of lead firm should be at least Rs 50 Lac during immediate three consecutive financial years. The firm shall attach CA turnover certificate.
- f) Net worth of lead firm shall be at least 60 Lacs.
- g) Should have on their rolls, adequate licensed personnel as required under I.E. act for carrying out work on electric panels and related electrical works.
- h) The firm should submit copy of VAT, ST, ESI, PF Registration certificate.
