Applications are invited from the officers of the Central Government / State Government / Union Territories / Universities / Recognized Research Institutions / Public Sector Undertakings / Semi Govt. / Statutory / autonomous organizations for appointment to the post of Deputy Curator (Archaeology) in Level 10 of Pay Matrix [Pre-revised-PB-3, Rs. 15600-39100 +5400/- Grade Pay] by deputation (including short term contract) in the National Museum, New Delhi.

2. Job Description

To conduct the specialized work of scholarly study, cataloguing, research, to contribute to publication, to carry on collection, safeguarding, exhibitions and interpreting for education and culture and the material in the field of Archaeology.

3. Eligibility

Officers under the Central Government / State Governments / Union Territories / Universities / Recognized Research Institutions / Public Sector Undertakings / Semi Government / Statutory or Autonomous Organizations.

M. Phil Degree of diploma in the relevant field from a recognized University/ Institute or equivalent.

Note 1.- The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short term contract) including the period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization / department of the Central Government shall ordinarily not exceed three years.

Note 3: The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.
