Notwithstanding the expiry of the period of 5 years, he/she may continue in office for not more than six months or till his/her successor is appointed and the latter assumes office, whichever, is earlier. iv. The Chancellor shall appoint the Vice Chancellor out of a panel of three names recommended by the Search-cum-Selection Committee. Thereafter, the proposal will be sent to ACC for approval. v. The period of deputation including the period of deputation in any other ex-cadre post held immediately preceding this appointment in the same or some other organisation / department of the Central Government shall ordinarily not exceed 5 years.
