The National Monuments Authority (NMA), a statutory body under the Ministry of Culture, constituted under the Ancient Monuments and Archaeological Sites and Remains Act, 1958 (as amended in 2010), invites applications from the eminent professionals with proven experience and expertise in the fields of Archaeology, Country and Town Planning, Architecture, Heritage, Conservation- Architecture or Law for appointment as Whole-Time Members (05) of the National Monuments Authority (NMA).

- 2. The eligibility criteria and service conditions for appointment as Whole-Time Member, are as under:
 - The Whole-Time Member shall be entitled to draw pay in the Higher Administrative Grade along with i. other allowances as are admissible to an officer of the rank of Additional Secretary to the Govt. of India. Provided that if a Whole-Time Member at the time of appointment is drawing a scale higher than the Higher Administrative Grade, his pay shall be protected as per the existing rules of the Government of India.
 - In case a person appointed as a Whole-Time Member, is in receipt of any pension, the pay of such ii. person shall be reduced by the gross amount of pension being drawn by him.
 - iii. The maximum age shall not exceed 67 years, on the last date of submission of application.
 - The tenure of Whole-Time Member shall be three years from the date on which he/she assumes office or till attaining the age of 70 years, whichever is earlier, and shall not be eligible for re-appointment.
 - Any person who has held any post in the Archaeological Survey of India or in the Ministry of Culture of the Government of India or a State Government or has not been found fit to be considered for being appointed to any such post, shall not be eligible to be appointed as a Whole-Time Member of the NMA.
 - Any person, who had either been granted a permission or license or refused any such permission or vi. refused grant of a license or any person or any of his/her relative having any interest in a prohibited area or a regulated area shall not be eligible to be appointed as a Whole-Time Member. For the purpose, "relative" means:
 - a. Spouse of the Chairperson or Member of the NMA;
 - b. Brother or sister of the Chairperson or Member of the NMA;
 - c. Brother or sister of the spouse of the Chairperson or Member of the NMA;
 - d. Brother or sister of either of the parents of the Chairperson or Member of the NMA;
 - e. Any lineal ascendant or descendant of the Chairperson or Member of the NMA;
 - f. Any lineal ascendant or descendant of the spouse of the Chairperson or Member of the NMA;
 - g. Spouse of the person referred to in clauses (b) to (f).
- vii. The person so appointed to the post of Whole-Time Member shall be entitled to CL/EL as applicable to serving government servants. However, he/she will not be entitled for LTC, leave encashment, medical allowance, government accommodation etc.
- The Headquarters of the Whole-Time Member shall be National Monuments Authority, 24, Tilak Marg, viii. New Delhi.
- 3. Interested and eligible eminent professionals from the relevant fields, as mentioned above, may submit their applications along with a detailed Curriculum Vitae (CV) in the prescribed proforma. In case of retired Government servants, a copy of Pension Payment Order (PPO) should also be attached.
