Vacancy Circular

Subject: Filling up the post of Deputy Curator (Exhibition), Group 'A', Gazetted, Non-Ministerial in PB-3, Rs. 15600-39100, Grade Pay of Rs. 5400/- by composite method [Deputation (including short term contract) plus promotion]] in the National Museum, New Delhi under the Ministry of Culture, Govt. of India.

Applications are invited from eligible officers for appointment to the post of Deputy Curator (Exhibition), Group 'A', Gazetted, Non-Ministerial in PB-3, Rs. 15600-39100, Grade Pay of Rs. 5400/- by composite method [Deputation (including short term contract) plus promotion]] in the National Museum, New Delhi under the Ministry of Culture, Govt. of India.

2. Job Description:

To assist Director General National Museum / Director (Exhibition & Public Relations) in planning and organizing exhibitions within India as well as abroad.

3. Eligibility

Officers under the Central Government or State Governments or Union Territories or University Recognized Research Institutions or Public Sector Undertakings or Semi Sector Undertakings or Semi Government or Statutory or Autonomous Organizations:-

(a) (i) holding analogous post on regular basis in the parent cadre or Department;

OR

(ii) with five years' service in the grade rendered after appointment thereto on a regular basis in posts in the pay band Rs. 9300-34800+4200/- Grade Pay (Pre-revised Rs. 6500-10,500) or equivalent in the parent cadre or Department;

OR

(iii) with eight years' service in the grade rendered after appointment thereto on a regular basis in post in the pay band of Rs. 9300-34800+4200/- Grade Pay (Pre-revised Rs. 5500-9000) or equivalent in the parent cadre or Department; and

(b) possessing the educational qualifications and experience as under:

Essential:-

- (i) (a) Master's degree from a recognized University or equivalent in History or Sanskrit or Pali or Prakrit or Arabic or Persian or Archaeology or Anthropology or Fine Arts or History of Art; and
- (b) Diploma in Museology from a recognized University or institution or equivalent.

OR

Master's degree from a recognized University or equivalent in Museology with History as a subject at Bachelor's degree level.

(ii) Three years' experience in planning and organizing of art and archaeology exhibitions in a Museum of national or regional importance under the control of Central Government or State Governments or Union Territories.

Desirable:-

M. Phil Degree in the relevant field from a recognized university or equivalent.

The departmental Assistant Curator (Exhibition) in Pay Band Rs. 9300-34800+4200/- Grade Pay with eight years regular service in the grade shall also be considered along with outsiders and in case he / she is selected for appointment to the post the same shall be deemed to have been filled by promotion.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization / department of the Central Government shall ordinarily not exceed three years.

Note 3: The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.

4. The applications in duplicate in the enclosed prescribed proforma (Annexure) and complete up to date ACR dossiers of the officer (last 5 years-Duly attested each page by an officer not below the rank of Under Secretary to the Govt. of India) who can be spared in the event of their selection along with (i) vigilance clearance, (ii) integrity certificate, (iii) cadre clearance, and (iv) major / minor penalty statement for the last 10 years should reach the **Under Secretary (M-I), Ministry of Culture, Room No. 210, D Wing, Shastri Bhawan, New Delhi – 110115** through proper channel within a period of **45 days** from the date of publication of the **corrigendum** in the Employment News. Applications received after the due date or otherwise incomplete will not be considered and will stand rejected.
