Societies/ Trusts/ Individuals etc registered in West Bengal**

Sir,

In compliance to the decision of the National Implementation Committee for commemoration of 150<sup>th</sup> birth anniversary of Swami Vivekananda in its third meeting on 24<sup>th</sup> March, 2012, I am directed to convey sanction of the President of India to the release of first installment of **Rs 2,00,00,000/- (Rupees Two Crore only)** against the approved grant of **Rs. 5.00 crore (Rupees Five Crore Only)** as **grant-in-aid to the State Government of West Bengal for disbursement to various NGOs/ Societies/ Trusts/ Individuals etc registered in West Bengal for commemoration of 150<sup>th</sup> birth anniversary of Swami Vivekananda.**

2. The above grant is subject to the following conditions:-

- (i) The grant shall not be utilized for any purpose other than the purpose for which it has been sanctioned.
- (ii) A certificate of the actual utilization for the above amount as also a statement of expenditure will be furnished to this Ministry by the Department of Information and Culture, State Government of West Bengal at the earliest and in any case within 12 months of the close of the financial year. Second and final installment will be disbursed after receipt of Utilization Certificate.
- (iii) A separate account for the grant shall be maintained which shall be open to audit by the Comptroller and Auditor General of India or any officer deputed by the Government at any time.
- (iv) Codal formalities will be followed wherever required.
- (v) All the projects financed from this grant will acknowledge/ display that the project / programme has been undertaken with the financial assistance of the Ministry of Culture, Government of India.


