**Subject: Commemoration of 150<sup>th</sup> Birth Anniversary of Swami Vivekananda-  
Sanction of grant to the Secretary, Department of Culture,  
Government of Uttarakhand, Secretariat, Dehradun.**

Sir,

I am directed to refer to the Directorate of Culture in Government of Uttarakhand letter No. 1496/S.N.U/Fire-52/2011-12 dated 5<sup>th</sup> September, 2011 and subsequent correspondence on the above subject and to convey sanction of the President of India to the release of first installment of **Rs 58,13,000/- (Rupees Fifty eight lakh thirteen thousand only)** against the approved grant of **Rs.1,39,90,000/- (Rupees One crore thirty nine lakh and ninety thousand Only)** as grant-in-aid to the Secretary(Culture), Government of Uttarakhand, Dehradun for construction of Swami Vivekananda memorial at Kakrighat involving construction of meditation hall, library, museum, Bridge and development of ghats and mounting of an exhibition of Swami Vivekananda in commemoration of 150<sup>th</sup> birth anniversary of Swami Vivekananda.

2. The above grant is subject to the following conditions:-

- (i) The grant shall not be utilized for any purpose other than the purpose for which it has been sanctioned.
- (ii) A certificate of the actual utilization for the above amount as also a statement of expenditure will be furnished to this Ministry by the Directorate of Culture, Government of Uttarakhand at the earliest and in any case within 12 months of this sanction. Second and final installment will be disbursed after receipt of Utilization Certificate.
- (iii) A separate account for the grant shall be maintained which shall be open to audit by the Comptroller and Auditor General of India or any officer deputed by the Government at any time.
- (iv) Codal formalities will be followed wherever required.
- (v) The projects financed from this grant will acknowledge/ display that the project / programme has been undertaken with the financial assistance of the Ministry of Culture, Government of India.
- (vi) Escalation cost, if may, will be borne by the State Government.



The above amount is debitable to Demand No.19, Ministry of Culture, 3601-Major Head Grants-in-aid to State Governments, 03- Grants for Central Plan Schemes (Sub Major Head), 201- Promotion of Art and Culture (Minor Head), 08- Centenaries and Anniversaries Scheme, 08.00.31- Grants in aid General (Plan) for the financial year 2013-14.

The amount of Rs.58,13,000/- will be drawn by the DDO(Special Cell), Ministry of Culture and paid to the Secretary(Culture), Government of Uttrakhand, Dehradun by the electronic transfer to their Account No. 10901525975 of State Bank of India, Branch at 4-Convent Road, Dehradun, Uttrakhand for a memorial of Swami Vivekananda at Kakrighat in Almora. IFSC Code is SBIN0000630 and MICR Code is 248002002. Mode of electronic transfer available is RTGS.

5. The above sanction is issued in exercise of the delegated powers and in consultation with IFD vide their Dy. No.761 dated 20.03.2014 and online certification of funds vide Dy. No.1379 dated 25.03.2014.


