**Subject: Grant-in-aid to Government of Maharashtra for non-recurring Plan expenditure (2013-14) for maintenance of Delivery of Books Act Section in State Central Library, Mumbai.**

Sir,

In supersession of this Ministry's letter of even number dated 8.11.2013, I am directed to convey the sanction of the President of India to the payment of Rs.18,75,000/- (Rupees eighteen lakhs and seventy five thousand only) as first installment of grant to the Government of Maharashtra as the Central Government's share of non-recurring Plan expenditure for maintenance of the Delivery of Books Act Section in State Central Library, Town Hall, Mumbai during the year 2013-14.

2. It is certified that the above amount of Rs.18,75,000/- (Rupees eighteen lakhs and seventy five thousand only) is being paid in accordance with the pattern of assistance as agreed to by the Ministry of Finance and the Government of Maharashtra. According to this pattern, the Government of India would bear 50% of the recurring expenditure and  $\frac{2}{3}$ <sup>rd</sup> of the Non-recurring expenditure on the Delivery of Books Act Section of the State Central Library, Mumbai.

3. The above amount is debitable to Demand No. 19, Ministry of Culture, 3601- Major Head Grant-in-aid to State Government, 04 Grants for Centrally sponsored Plan Scheme 202- Art and Culture – Public Libraries (Minor Head), 02- Central Library, Mumbai, 02.00.31- Grant-in-aid General under Plan for the current financial year 2013-14.


4. The amount of Rs.18,75,000/- (Rupees eighteen lakhs and seventy five thousand only) will be placed at disposal of the State Government by the Principal Accounts Officer, Ministry of Culture through RBI, Central Accounts Sectt., Nagpur as early as possible but in any case not later than 31.3.2014.


