- 5. The amount of Rs. 2,50,000/- (Rupees Two lakh fifty thousand only) will be placed at the disposal of the State Government by the Principal Accounts Officer, Ministry of Culture, through RBI, Central Accounts Secretariat, Nagpur, as early as possible, but in any case not later than 31.03.2014.
- 6. The above sanction is issued in exercise of the delegated powers and in consultation with **IFD vide their Dy. No. 906 dated 29.03.2014**. The availability of funds has been certified online (electronically) vide this Scheme **Dy. No.1481/2014 dated 31.03.2014**.
