Sub:- Grant-in-aid to Government of Mizoram for non-recurring Plan expenditure (2014-15) as part payment of first instalment in connection with the construction of **Tagore Cultural Complex, Aizawl, Mizoram** under TCC Scheme(NE Head).

Sir,

I am directed to convey the sanction of the President of India to the payment of Rs.3,45,00,000/- (Rupees Three crore and forty five lakh only) as the Central Government's share of non-recurring Plan expenditure to <u>the Government</u> <u>of Mizoram</u> as part payment of first installment of Rs.4,50,00,000/-(Rupees Four crore fifty lakh only) out of the Central Government's share of Rs.9,00,00,000/- (Rupees Nine crore only) equivalent to 50% of 1<sup>st</sup> installment of Central Govt. Share in connection with Construction of Tagore Cultural Complex, Aizawl, Mizoram under the Scheme for Tagore Cultural Complexes.

2. It is certified that the above amount of **Rs.3,45,00,000/- (Rupees Three crore and forty five lakh only)** is being paid in accordance with the provisions of the aforesaid Scheme.

3. The second installment of the sanctioned amount would be released by the Ministry of Culture on submission of the following documents and subject to availability of funds:

- (i) Physical and financial progress report on the project, giving details of the work already carried out/ completed, along with certified photographs of the site.
- (ii) A utilization certificate from Chartered Accountant, certifying that the first instalment of assistance has been fully utilized for the project.
- (iii) The audited statement of accounts of the project duly signed by a Chartered Accountant, showing that the first instalment as also the proportionate matching share provided by the State Government has been utilized for the project.
- (iv) A certificate from State PWD/ CPWD or a registered Architect to the effect that
  - i. the project is in progress as per the approved plan;
  - ii. there has been no violation of the local laws and the approved plan of construction/ development;
  - iii. the work done is of satisfactory quality; and
  - iv. valuation of the cost of work done and the further amount required to complete the project.
  - v. Any other document as requested by the Central Government from time-to-time.



14. The State Government shall be bound to submit from time to time such report, statements, etc. in respect of expenditure from this grant as might from time to time be required by the Ministry.

15. No funds out of this grant should be utilized for any new scheme without prior approval of the Government of India.

16. The above sanction is issued in exercise of the delegated powers and in consultation with IFD vide their Dy. No.939 dated 27.03.2015.

17. Grant sanction has been entered in the Grant-in-aid Register at SI. No.14.
