G.S.R.....In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Library and Information Officer in the Central Reference Library, Kolkata, namely: -

1. Short title and commencement. —(i) These rules may be called the Ministry of Culture, Central Reference Library, Kolkata, Library and Information Officer (Group 'A' post) Recruitment Rules, 2024.

(ii) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and level in pay matrix. — The number of the said post, classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age limit, qualifications, etc. — The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in column (5) to (13) of the aforesaid Schedule.

- 4. Disqualification. No person-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule. 5. Power to relax. — Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Savings. — Nothing in these rules shall affect reservations, relaxation of agelimit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

b) possessing the following educational qualification and experience -

Essential:

(i) Master degree in Library Science or Library and Information Science of a recognised University or institute.

(ii) 5(Five) years professional experience in a Library under Central Government or State Government or Union territory or autonomous or statutory organisation or public sector undertaking or recognised University or recognised research institution.

Desirable:

(i) One year experience of computerizing Library activities in a Library under the Central Government or State Governments or Union territories or autonomous or statutory organization or public sector undertaking or recognized University or recognized research institution.

(ii) Diploma in computer application from a recognized University or Institution.

Note 1: The departmental officer in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly deputation shall not be eligible for consideration for a appointment by promotion.

Note 2: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the central government shall ordinarily not exceed four years.

Note 3:The maximum age limit for appointment by deputation (including short term contract) /absorption shall be 'not exceeding 56 years as on the closing date of receipt of application.

Note 4: The provision for absorption will be applicable in the case of Central or State Government and Union Territory Government officials only.
